Further to the Company's announcement on 11 June 2010, Mechmar wishes to announce that it will not be making an appeal to Bursa Malaysia Securities Berhad ("Bursa Malaysia") in respect of Bursa Malaysia's notice to de-list Mechmar from the Official List of Bursa Malaysia. As such, the securities of the Company will be removed from the Official List of Bursa Malaysia on Monday, 21 June 2010.

**Effect of de-listing:-**

- 1) Upon the de-listing of the Company, Mechmar will continue to exist but as an unlisted entity. Shareholders will be holding shares which are no longer quoted and traded on Bursa Malaysia.
- 2) Shareholders of the Company who intend to hold their securities in the form of physical certificates, can withdraw these securities from their Central Depository System (CDS) accounts maintained with Bursa Malaysia Depository Sdn Bhd ("Bursa Depository") at anytime after the securities of the Company have been de-listed from the Official List of Bursa Malaysia. This can be effected by the shareholders submitting an application form for withdrawal in accordance with the procedures prescribed by Bursa Depository.
